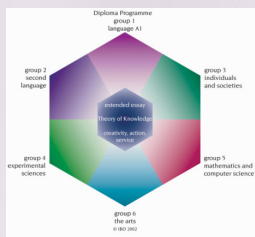
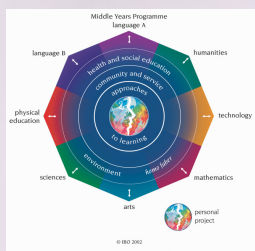
## Find The Right Answers

The 2007 Teachers Convention is designed to provide participants with three different ways to explore the theme of “Information Literacy Across the Programmes”:

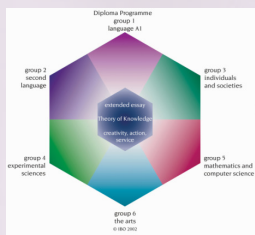
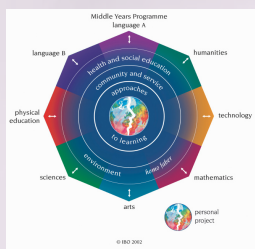
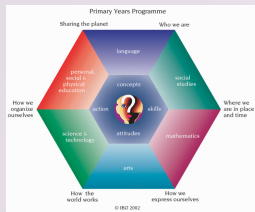
1. **Plenary Sessions** during which respected keynote speakers and stakeholders will introduce the fundamental challenges which schools face in regard to information literacy and education.
